

MSc in Data Science and Machine Learning (MDSML) Tuition Fees Structure for 2024 Intake

(Singapore Citizen/Singapore Permanent Resident Students)

For AY2024/2025, all Singapore Citizens and Singapore Permanent Residents enrolling into the MDSML programme will be automatically extended with a <u>40%</u> tuition fee rebate¹ for courses that are not covered by government subsidy. This rebate will be automatically extended, and students need not apply for it.

❖ Acceptance Fee:

Early Admission	SGD 5,400 (inclusive of prevailing GST) *Acceptance fee paid in 2023.
Regular Admission	SGD 5,450 (inclusive of prevailing GST)

This is a one-time payment upon offer acceptance. Acceptance fees is <u>non-refundable and non-transferrable</u>.

- Full-time and part-time Singapore Citizen / Singapore Permanent Resident students will be billed based on the number of courses read per semester (pay by per-course fee).
- Singapore Citizens and Singapore Permanent Residents who enrolled to the SSG-funded courses which are skills-based and industry-relevant may be eligible to receive 70% subsidy. For Singapore Citizens aged 40 years old and above, the subsidy may be up to 90%.
- Please note that SSG funding can only be used for at most 5 elective courses.
